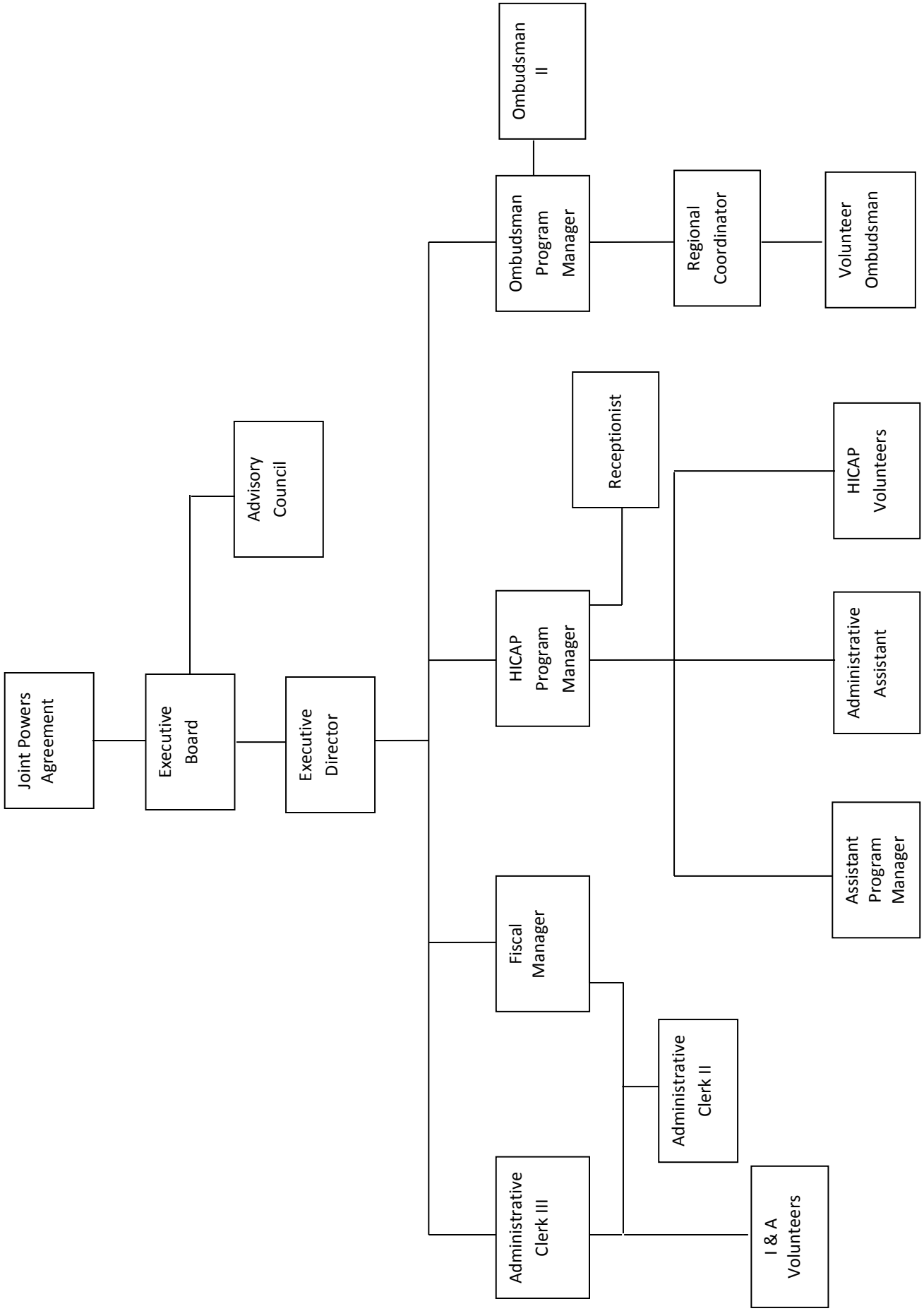


PSA 2 Area Agency on Aging Organizational Chart
